On April 1, 2020, Governor Whitmer issued Executive Order 2020-33, which declared both a state of emergency and a state of disaster across the State of Michigan due to the spread of the novel coronavirus (COVID-19). The critical mitigation measures include social distancing and limiting the number of people interacting at public gatherings.
