Felony Warrant Arrest for Probation Violation

Officers on routine patrol conducted a traffic stop on a vehicle. The driver, a 26-year-old Hazel Park man was found to have three (3) felony probation violation warrants for his arrest from the 16th Circuit Court. The subject was arrested for the warrants.

Concealed Weapons-Firearm in Auto and Driving While License Suspended Arrest

Officers on routine patrol conducted a traffic stop on a vehicle. The driver, a 30-year-old Farmington Hills man, was driving on a suspended license and had a loaded firearm in his vehicle. The passenger, a 31-year old Garden City man, had a probation violation warrant for his arrest. Both subjects were arrested for the offenses.

Now that winter is here residents and visitors are reminded of Royal Oak's Snow Emergency Ordinance. Snow Emergency conditions are generally defined as ***a snowfall of four inches or more and will remain in effect until your street has been plowed.*** All vehicles on residential streets are to be removed or will be ticketed or towed. Vehicles are to remain off the streets until plow trucks have gone through the area. Once a snow emergency is called and plowing begins, it takes approximately 24-36 hours to plow all city streets, depending on how much snow has fallen.
