Additional Incidents and Information

Home Invasion, Felonious Assault, and Assault and Battery Suspect Arrested

On Wednesday, November 11, 2020, at approximately 10:42 a.m., officers responded to an apartment complex in the 4400 block of Judson Ave for a female assaulting the caller. Officers arrived and spoke with the caller who stated he allowed another tenant to spend the night due her having an argument with her girlfriend. The girlfriend came to his apartment and when he answered, she pushed him back and forced her way into the apartment.

Another person attempted to call 911 and the suspect punched her in the face causing a swollen eye. The suspect then picked up a flowerpot and threw it at another female almost hitting her in the head. The male tenant pushed the suspect out of the apartment, and she left in her vehicle. She later returned and spoke with the officers.

The 25-year-old resident of Royal Oak suspect was arrested for Home Invasion, Felonious Assault, and Assault and Battery.
